How to enter: Digital photos may be submitted by emailing your photo to contest@prtcnet.org
Printed photographs may be dropped off at your local PRTC office or mailed to:

Photographs will not be returned unless otherwise requested along with return address included with the submission.

Winners: Winners will be notified approximately 1-2 weeks after the contest deadline by email and/or phone. Winners will also be announced on the PRTC website, social media and PRTC TV. Photographs, along with the photographer's name and information about the photo, may be displayed on the PRTC website, social media and PRTC TV.

Submitting Photos: Digital photos should be submitted by email to contest@prtcnet.org
Digital photos must have a minimum resolution of 2000 x 1600, photo size of 8 x 10 inches, and/or a file size of 700k or higher. Digital photos should be submitted in JPEG/JPG format (at high quality). Printed photos should be no smaller than 4 x 6 inches. All contest photos must be in natural color. *Black and White photos will not be accepted.*

Photo Location: The photo must have been taken recently in Jackson or Owsley Counties, Kentucky.

Photo Formats: Entries may be digital photos (sent via email) or printed photographs. *Please read the specific guidelines for submitting digital photos.*

Photographer/Copyright: Photographer must be a current PRTC member. Entries must be submitted by the original photographer. **Do not submit a photo taken by someone other than you.** You must be the sole owner of the copyright of any photo submitted. Your submission of the photo and entry form is your guarantee that you are the owner of the photo.

Photo Subject Restrictions: Photos must be appropriate for posting publicly. Obscene, provocative or otherwise questionable content will not be considered. PRTC retains sole discretion as to what constitutes inappropriate content. Photos containing recognizable people must be accompanied by a signed photo release form, included on the contest entry form.

Ownership/Use Rights: Photographers retain the copyright to their photographs. By entering the contest, photographers agree to have their submitted photograph be included in the Peoples Rural Telephone Cooperative (PRTC) Directory and calendar. Photographers also consent to let PRTC use their photographs in marketing/communications project or projects without any fee or other form of compensation. Photographer agrees that PRTC may display the photo(s) in a photo gallery on the PRTC website and may make and retain copies of the photograph for archival purposes. Photos will be credited to the photographer named in the entry form. Entries will never be used by PRTC in any manner for sale. In the event that ownership of any photograph submitted to PRTC is contested, PRTC retains the discretion to disqualify that photograph and discontinue use of the photograph. All photographs may be displayed on the Peoples Telecom/PRTC TV Channel 9, PRTC websites, PRTC YouTube channel and/or PRTC Facebook page for viewing and/or judging.

Other Important Information: PRTC and its employees, board members and their families are not eligible to enter this contest. PRTC is not responsible for computer system, hardware, software, or program malfunctions or other errors, failures, or delayed computer transactions or network connections that are human or technical in nature. Furthermore, PRTC is not responsible for: (i) lost, misdirected, misplaced, illegible, unintelligible, incomplete, or late entries or (ii) any act, failure to act, or delay regarding the transmitting or processing of entries. PRTC reserves the right, in its sole discretion, to cancel or suspend all or any portion of this contest without notice if factors beyond PRTC's control, including technical difficulties, disrupt or corrupt the fair or secure administration or operation of the contest. Void where prohibited. PRTC is entitled to interpret these rules as needed and its decisions are final.
